REQUIREMENTS

- You must be a current undergraduate (junior or senior) or graduate student enrolled in a university program with an anticipated graduation date of Winter 2022 or later.
- Students must have at least a final semester of schoolwork to finish after the internship program.
- If you want to obtain university course credit, you are responsible for accreditation and documentation.
- Students must be able to work in a standard office environment. Work is generally done sitting, talking, hearing, and typing. Visual acuity to use a keyboard, view onscreen, prepare and analyze data; extensive reading.
- All applicants will be required to submit to a criminal background check prior to hire because of the nature of business.
